

SUPPLEMENTAL HURRICANE INSURANCE

How Payouts Are Determined



HOW IT WORKS

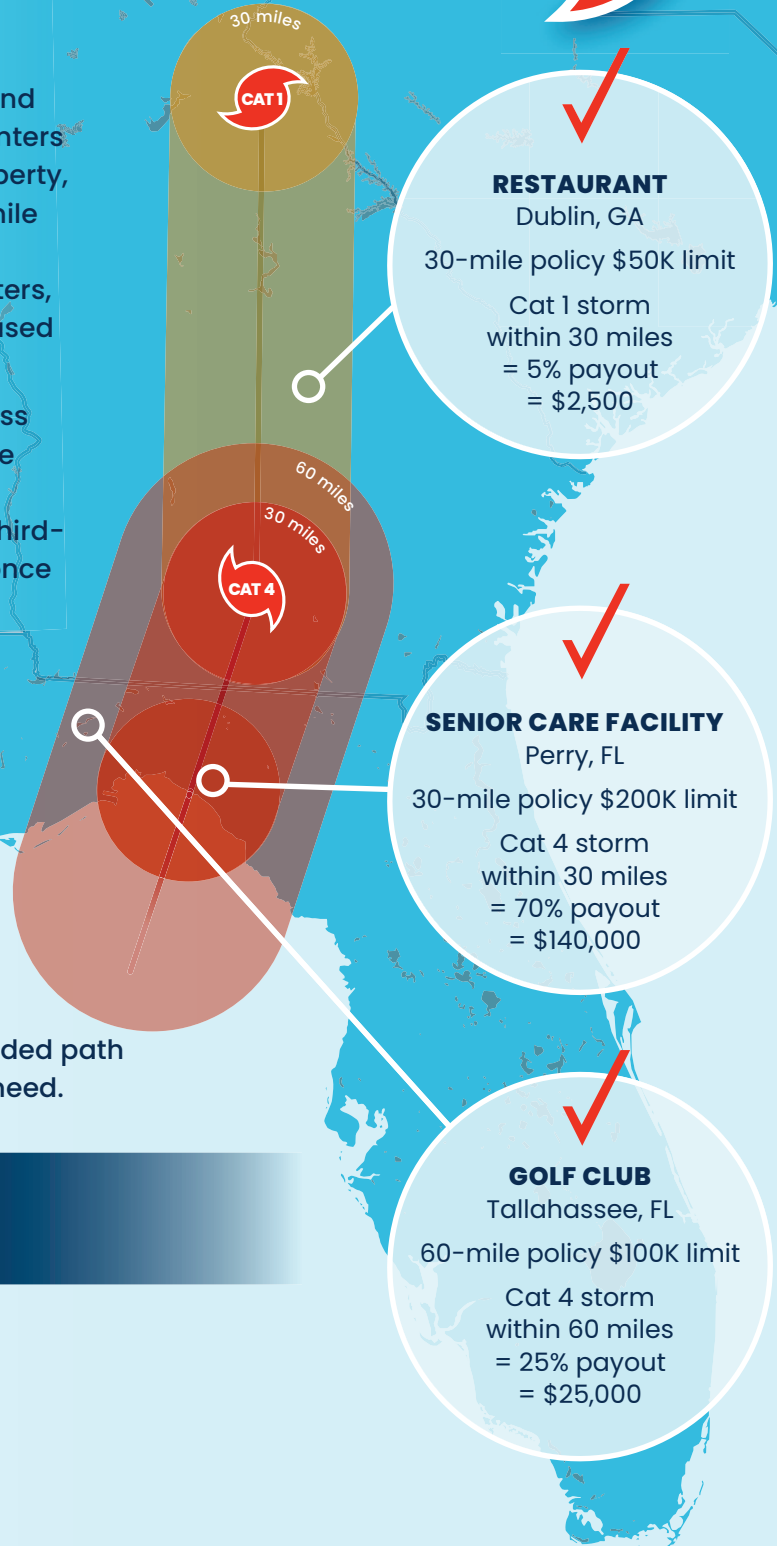
You choose your coverage radii, 30 or 60 miles around your business. If the recorded track of a hurricane enters the 30-mile coverage area that surrounds your property, you receive a payout in less than 30 days. The 60-mile policy covers major hurricanes only (Category 3 or higher). No peril exclusions, financial records, adjusters, or inspections are needed, and payouts increase based on the storm's proximity and intensity.

This product covers flood, storm surge, wind, business interruption, and any other financial loss. Policies are activated 30 days after signing and last 12 months. Claims are automatic and based on independent third-party data from the National Hurricane Center, so once a policy is bound, you're all set. It's that simple.

The map represents the storm track of Hurricane Helene and examples of three businesses in the hurricane's path, as well as example policy details and payout amounts.
